Guaranty Abstract Company understands that the security of your financial information is important. We provide this notice in accordance with applicable state and federal laws to help you understand what types of nonpublic personal information — information about you that is not publicly available — we may collect, how we use it and how we protect your privacy.

Guaranty Abstract Company Privacy Policy

- We collect nonpublic personal information, including Social Security numbers and/or tax identification numbers, to process and administer our customers' business.
- We have policies and procedures in place to protect nonpublic personal information, including Social Security numbers and/or tax identification numbers, about our customers.
- We do not sell nonpublic personal information about our customers to third parties, i.e., companies or individuals that are not affiliated with Guaranty Abstract Company.
- We do not disclose any nonpublic personal information about our customers to anyone, except as permitted by law or for which you have provided your consent.
- Our Privacy Policy applies to both current and former customers.

Types of information collected

- Guaranty Abstract Company employees, representatives, agents and selected third parties may collect nonpublic personal information about our customers, including:
 - Information provided to us, such as on applications or other forms
 - Information about transactions with us, our affiliates or third parties
 - Information from others, such as credit reporting agencies, employers and federal and state agencies
- The types of nonpublic personal information Guaranty Abstract Company collects vary according to the products or services provided and may include, for example: account balances, income, assets, insurance premiums, credit reports, including Social Security numbers and/or tax identification numbers, marital status and payment history.

Protection of nonpublic personal information

- We restrict access to nonpublic personal information, including Social Security numbers and/or tax identification numbers, to those employees, agents, representatives or third parties who need to know the information to provide products and services to our customers.
- We have policies and procedures that give direction to our employees, and agents and representatives acting on our behalf, regarding how to protect and use nonpublic personal information, including Social Security numbers and/or tax identification numbers.
- We maintain physical, electronic and procedural safeguards to protect nonpublic personal information, including Social Security numbers and/or tax identification numbers.

Sharing of nonpublic personal information

- We do not share nonpublic personal information about our customers with anyone, including our affiliates, except as permitted by law or with companies for which you have provided your consent.
- We may disclose, as allowed by law, all types of nonpublic personal information we collect, to Guaranty Abstract Company agents, employees, and representatives, as well as third parties that administer and service customer accounts on our behalf.

Application of Privacy Policy

- Guaranty Abstract Company's Privacy Policy applies, to the extent required by law, to its agents and representatives when they are acting on behalf of Guaranty Abstract Company.
- Please note: There may be instances when these same agents and representatives may not be acting on behalf of Guaranty Abstract Company, in which case they may collect nonpublic personal information on their own behalf or on behalf of another. In these instances, Guaranty Abstract Company's Privacy Policy would not apply.
